
NATIONAL INSTITUTES OF HEALTH Budget Process Calendar



FORMULATION:

March-April With input from the ICs, the Director identifies underlying philosophy and NIH priorities for proposed allocation of funds including specific areas of emphasis.
May-July A formal Budget Retreat or informal meetings are held with IC Directors to discuss proposals and make recommendations.

- NIH prepares materials and articulates priorities for the Department of Health & Human Services (HHS) submission and defends the NIH requ
- Aug. Sept. NIH prepares and transmits documentation to support U.S. Office of Management & Budget (OMB) submission that follows from SBC decision
- Nov-Dec NIH Director may appeal budget at time of the OMB Passback.
- Dec-Jan NIH develops President's Budget (PB) and Congressional Justification (CJ) in accordance with NIH priorities and Administration policy as e. April or May in Presidential transition years.)

PRESENTATION:

- Feb-March NIH submits the CJ that conveys narrative, tables, images and graphs that describe and justify the PB. (In a Presidential transition year or y budget occurs after February and can be delayed until April or May).
- Spring NIH and IC Directors testify to defend the PB before the Labor/HHS House and Senate Appropriations Subcommittees. (In a Presidential tra PB submission occurs later than February).

Summer House/Senate Appropriations Subcommittees should mark-up the levels in the PB by IC.

- Aug-Sep Conferees from the House/Senate Appropriations Subcommittees should resolve any differences between dollar levels and guidance (including in response to the PB. Guidance from one Subcommittee not reported in the other or in Conference remains in effect.
- Sept-Dec. The Congress appropriates funds for each Institute or Center (IC), the Office of the Director (OD), and the Buildings & Facilities (B&F) progra (CR) must be passed to sustain operations at the previous FY level.

Sep 30	End of the fiscal year-books closed. No further new obligations of budget authority incurred for fixed period of availability accounts, i.e. one-year	
Oct-Nov	Reconciliation of accounts and compilation of actual results for the recently ended (expired) year.
